**Subject:** Disaster Sheltering for Animals Course - Signup info - March 4 & 5 - Little Rock

The Humane Society of Saline County in conjunction with the Emergency Management Program of Arkansas Children's Hospital is proud to bring the *American Humane Association's* **Disaster Sheltering for Companion Animals** course to central Arkansas.

Important facts:

- Space is very limited, so sign up now!
- Two day course, \$65 enrollment fee, materials included

If you will be paying by check, click the "Print Form" button and send it and your check to the address on the form. If you'd like to pay by PayPal, fill out the information and click the "Submit by Email" button. Within 48 hours you will receive a PayPal invoice for the course fee. Regardless of which method you use, once your payment has been received you will receive an email with confirmation of your enrollment.

Course Information:

This two-day course presented by the American Humane Association focuses on how to plan for and implement emergency sheltering for companion animals during or after a disaster and should be considered "must-have" training for every community. This class teaches important skills for planning and implementing emergency sheltering for companion animals. FEMA recommends that emergency plans include provisions for sheltering service and companion animals ...are you prepared?

The objective of this course is to develop the skills to plan for and implement emergency sheltering for companion animals during or after a disaster, whether at the local or national level. People who should attend include anyone interested in the welfare of animals during or after a disaster, professionals trained in disaster response, emergency medical services personnel, firefighters, animal shelter staff, animal control officers, veterinarians and vet technicians, animal handlers/trainers and Red Cross volunteers.

Large businesses, hospitals, corporations: would you need your key employees to still report to work in the event of a large disaster? Roughly 60% of Americans have at least one pet. Therefore, if you need your vital personnel to report to work in a crisis where they may be required to stay for an extended period of time, you should be prepared to offer shelter for their pets as well. Would you know where to start?

Hospitals, churches, schools and other public places: these places could all become sheltering locations for people during a large disaster...are you prepared to shelter, feed and care for their pets?

Class hours are 9am until 5pm each day. Lunch may not be provided (still working on that!) but there will be morning and afternoon snacks. It is not necessary to have a membership with the AHA to attend this class.

Directions to Electric Cooperatives of Arkansas:

From Downtown LR area:

Heading west on I-30, take the Scott Hamilton Street Exit. Go left at the red light, over the overpass, and straight through the next stop light. The first street on the right, past the Red Roof Inn, is Cooperative Way. Turn right.

From Bryant/Benton area:

Heading east on I-30, take the Scott Hamilton Street Exit and turn right on first driveway.
